Primary Elements Checked During COI Review

- > Has the certificate expired (policy expiration date has passed or will pass before the first day of camp.)
- > Do the camp dates fall within the policy effective and expiration dates?
- Is there an "X" next to sexual abuse and molestation as indicated in the above example?
- Is there an "X" next to automotive liability (if transporting minors) as indicated in the above example?
- Is University of Central Florida Board of Trustees listed as the certificate holder?
- Is University of Central Florida Board of Trustees included as an Additional Insured (An "X" should be shown in the additional insured column on the certificate for general liability and automotive liability).
